Dear Prospective Fort McDowell Vendor,

The Fort McDowell Tribal Gaming Office, a regulatory agency of the Fort McDowell Yavapai Nation, has been authorized to license all vendors who provide goods or services to the Fort McDowell Gaming Center. You should apply for a Class B license if your company will provide the Gaming Center with goods and services in an amount less than \$10,000 per month. You should apply for a Class A license if you anticipate exceeding the \$10,000 limit or if you provide certain gaming-related goods or services.

The Privacy Statement and the second page of the application require a notarized certification by the owner, a corporate officer or the Arizona regional manager who completes the Owner/Principal Officer section of the application.

Please send the completed application to the address below. Vendors that provide goods or services to the Fort McDowell Gaming Center must pay a \$50.00 licensing fee, payable to the Fort McDowell Tribal Gaming Office.

According to our purchasing statistics, contracts or agreements, the fee for your company is: \$50.00, due with the completed application.
